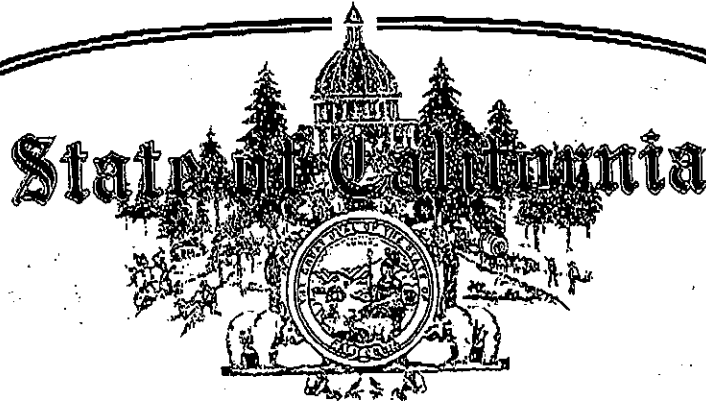

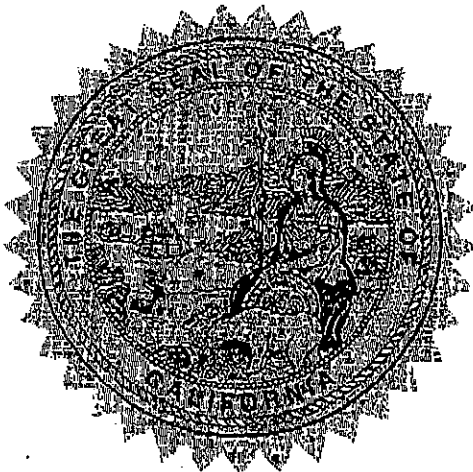

ARTICLES OF INCORPORATION
of
Friends of YOSAR, Inc.

Article I

The name of this corporation is FRIENDS OF YOSAR, INC.

Article II

A. This corporation is a non-profit public benefit corporation and is not organized for the private gain of any person. It is organized under the Non-Profit Public Benefit Corporation Law for charitable purposes.

B. The purposes of this corporation are to support the work and mission of Yosemite Search and Rescue ("YOSAR") in protecting the safety of climbers, hikers, and other recreationists in Yosemite National Park and other national parks within the region, and to advance education and knowledge of, and skill in, search and rescue.

Article III

The name and address in the State of California of this corporation's initial agent for service of process is:

Article IV

A. This corporation is organized and operated exclusively for education and charitable purposes through support of and education about search and rescue within the meaning of Section 501(c)(3) of the Internal Revenue Code.

B. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from Federal Income Tax under Internal Revenue Code Section 501(c)(3), or which receives contributions deductible under Internal Revenue Code Section 170(c)(2).

C. No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not


participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.

Article V

The property of this corporation is irrevocably dedicated to educational purposes meeting the requirements of California Revenue and Taxation Code Section 214, and no part of the net income or assets of the organization shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private person. Upon the dissolution or winding up of the corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a non-profit fund, foundation or corporation which is organized and operated exclusively for educational purposes (meeting the requirements of California Revenue and Taxation Code Section 214) and which has established its tax-exempt status under Section 501(c)(3) of the Internal Revenue Code.


